


Fig. 2 - Typical Values of Reverse Current vs. Reverse Voltage




Fig. 3 - Typical Junction Capacitance vs. Reverse Voltage





Fig. 4 - Maximum Thermal Impedance Z_{thJC} Characteristics



 $\label{eq:dlf} dl_f/dt \, (A/\mu s)$ Fig. 6 - Typical Recovery Current vs. dl_f/dt




Fig. 7 - Typical Stored Charge vs. dl_F/dt





Fig. 8 - Typical dI_{(rec)M}/dt vs. dI_F/dt






