




Fig. 1 - Forward Current vs. Forward Voltage




Fig. 2 - Admissible Power Dissipation vs. Ambient Temperature




Fig. 3 - Typical Capacitance vs. Reverse Voltage







Fig. 4 - Typical Reverse Leakage Current vs. Reverse Voltage



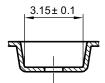


