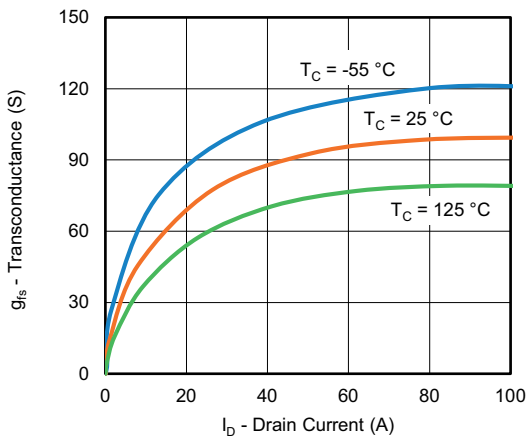

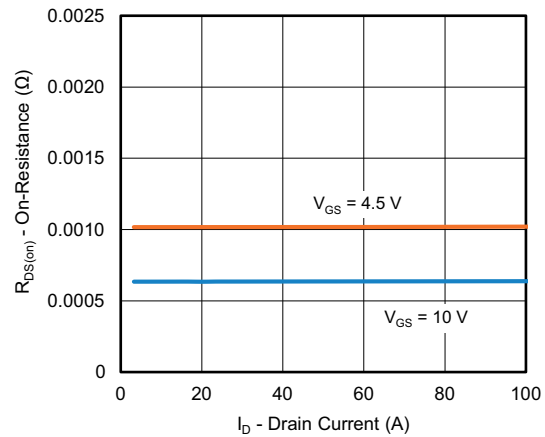

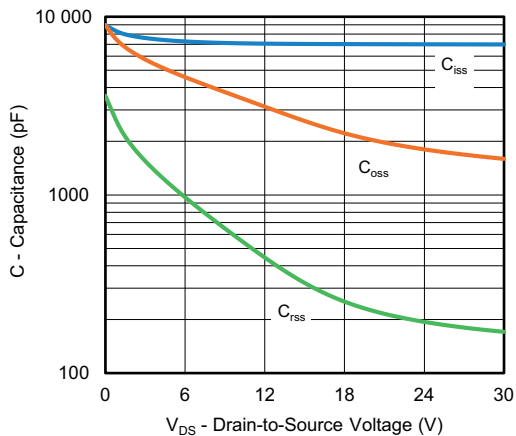

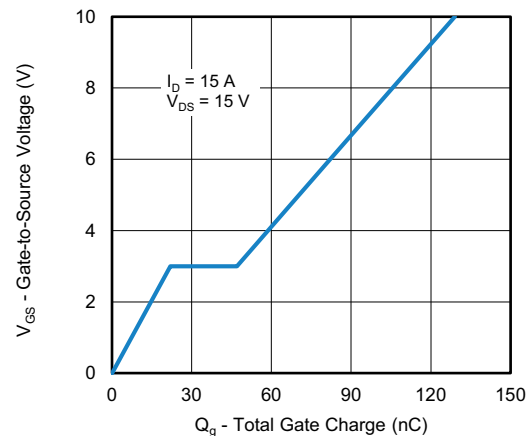

On-Resistance vs. Drain Current



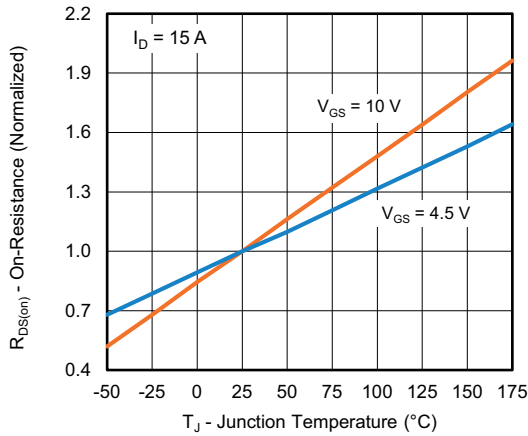

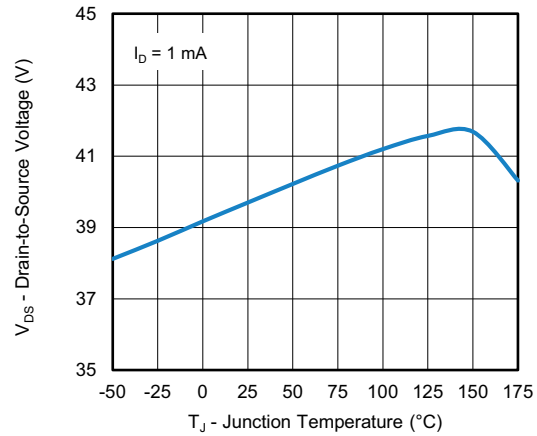

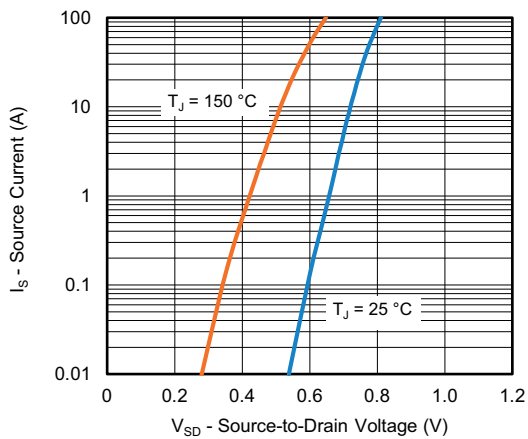

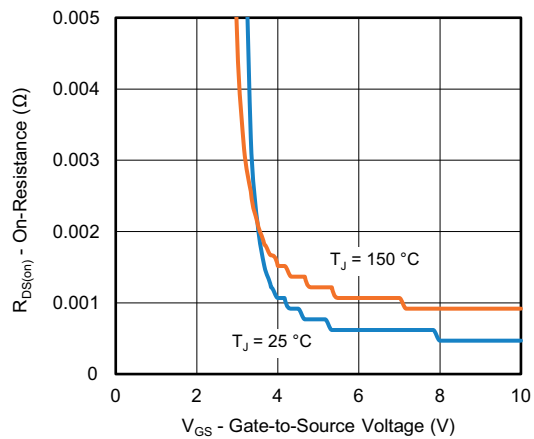
On-Resistance vs. Junction Temperature



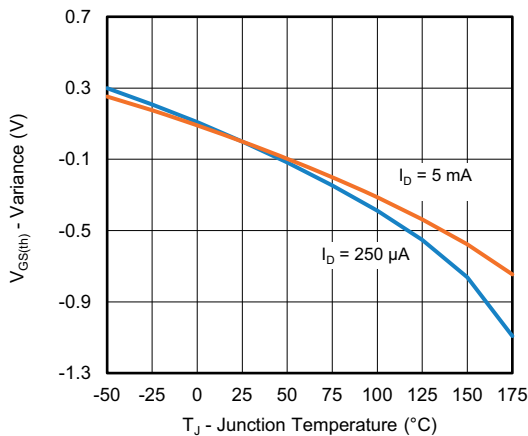
Drain Source Breakdown vs. Junction Temperature



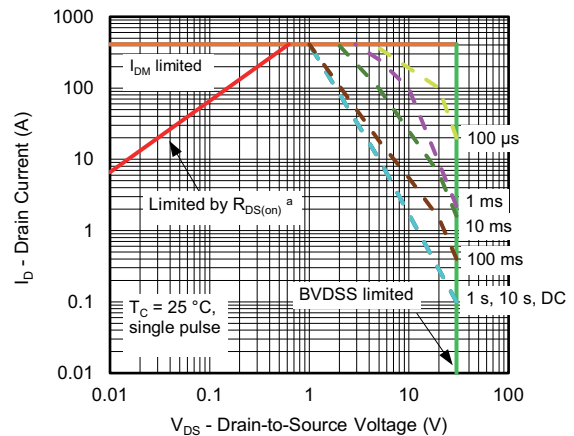
Source Drain Diode Forward Voltage

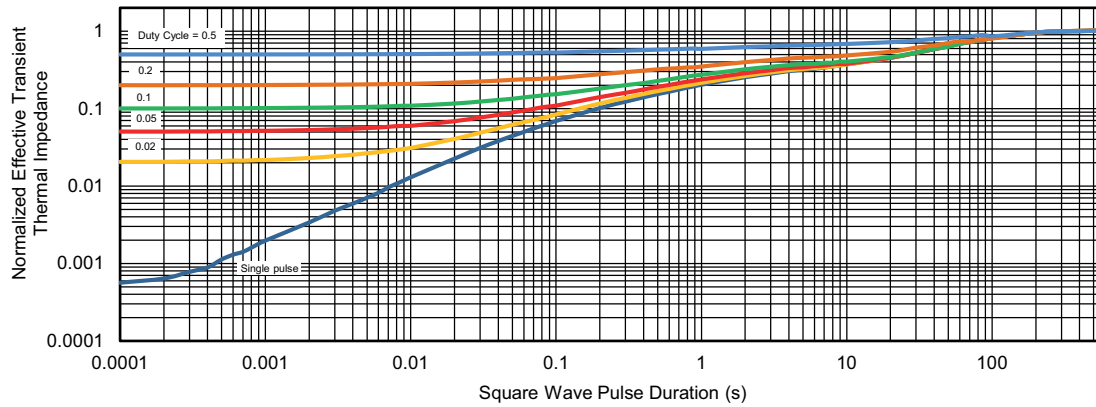

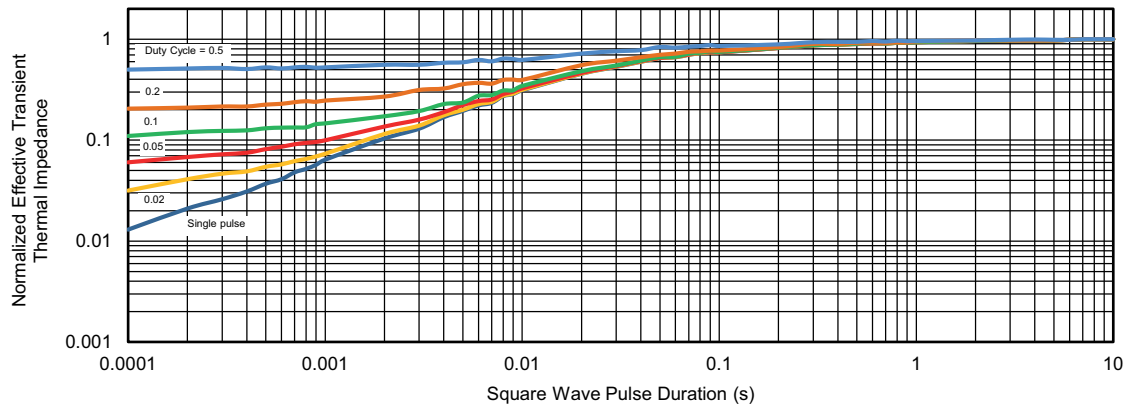

**Normalized Thermal Transient Impedance, Junction-to-Case**

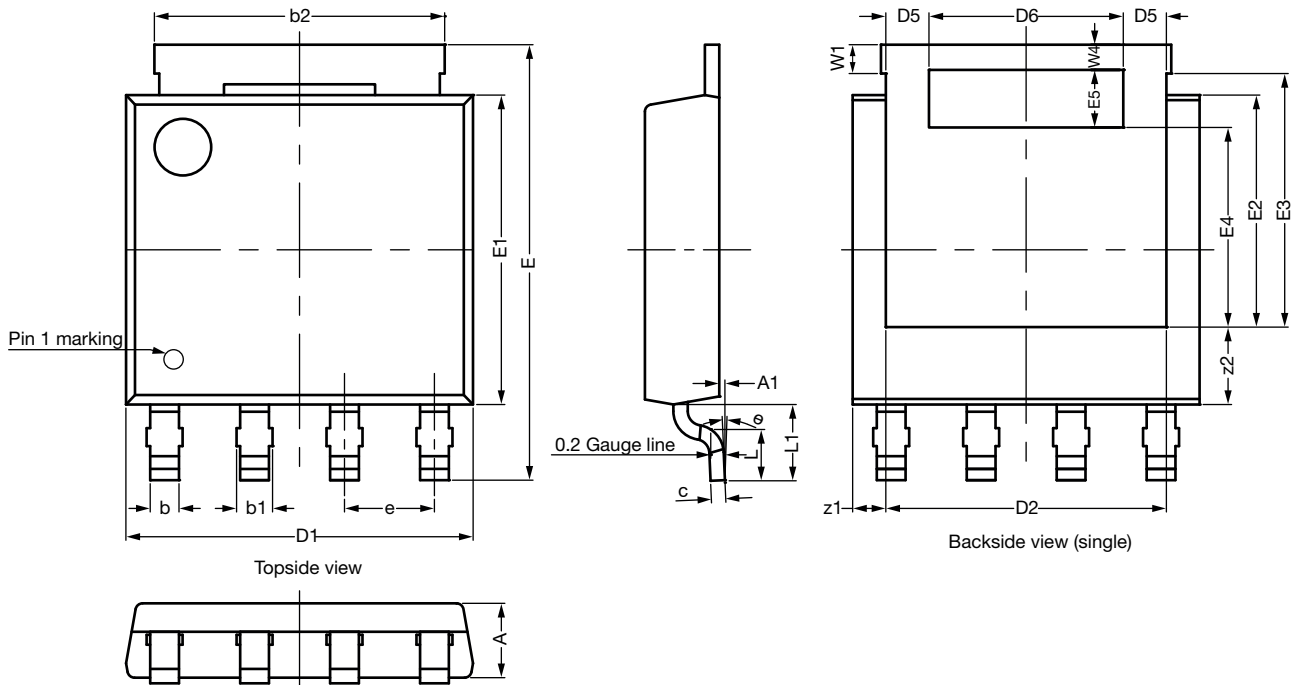

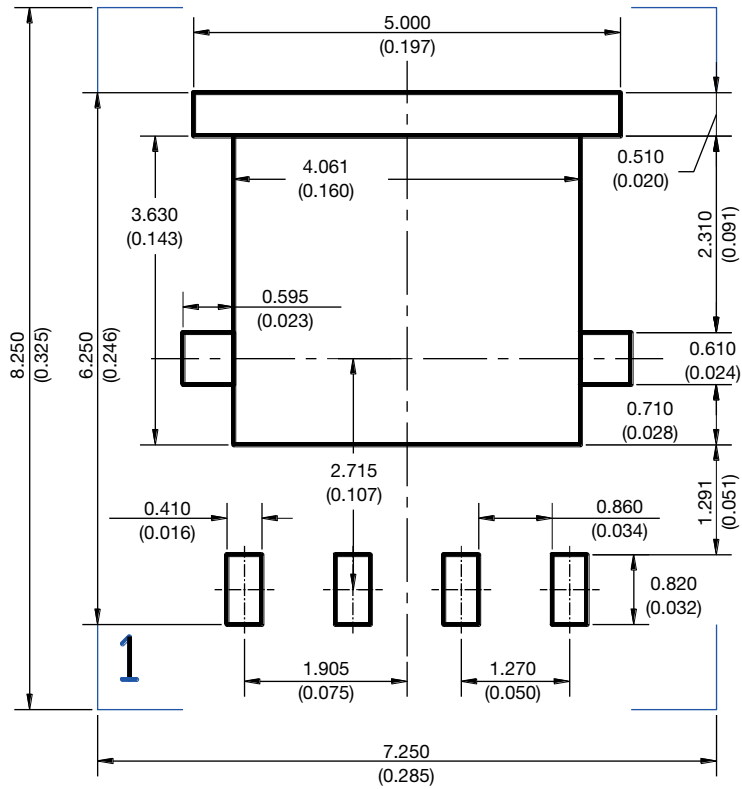

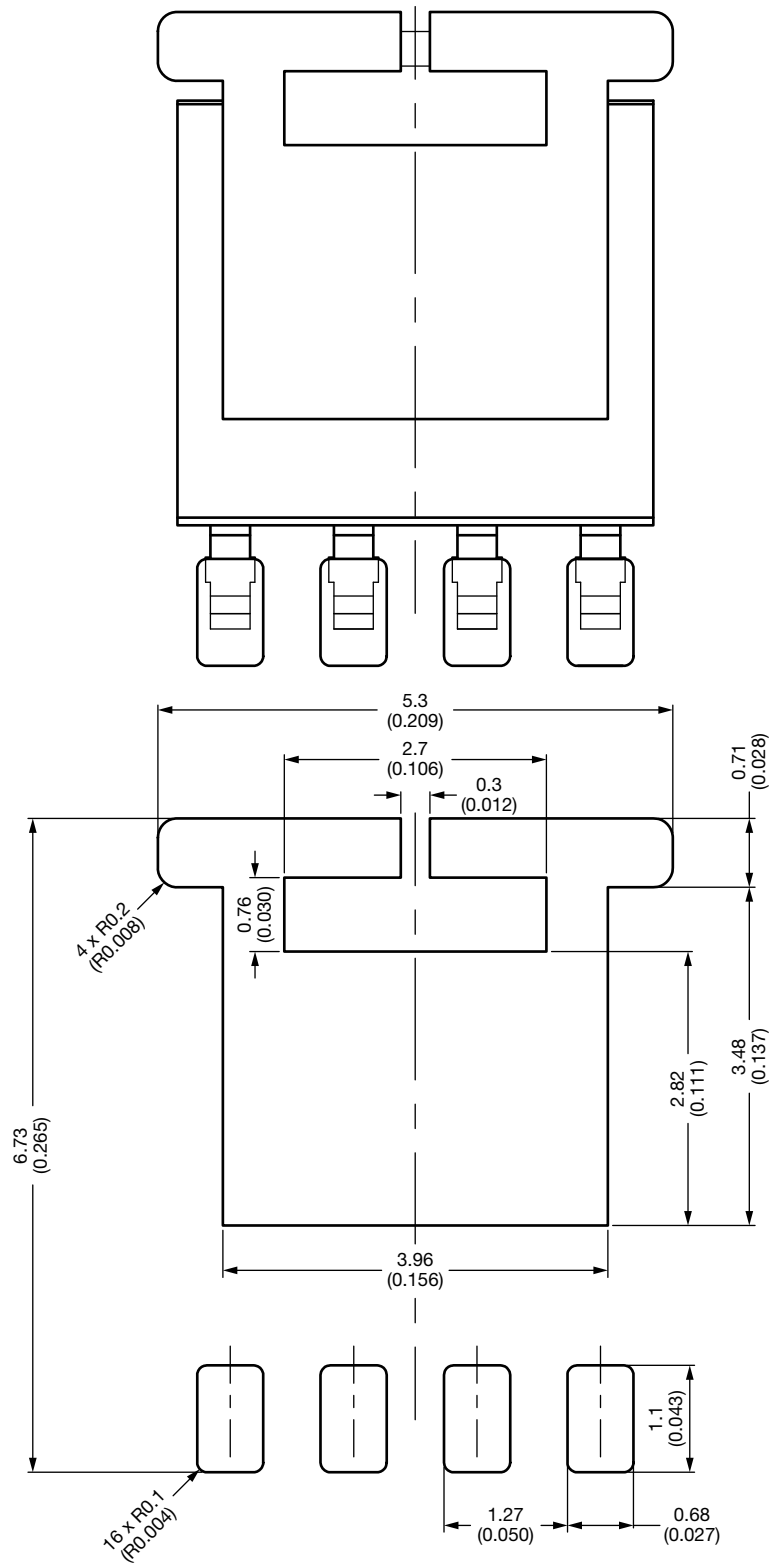
**RECOMMENDED MINIMUM PAD FOR PowerPAK® SO-8L SINGLE**
