

DESCRIPTION

As part of the [SurfLight™](#) portfolio, the VSMY14940UL is an infrared, 940 nm, side looking emitting diode based on GaAlAs surface emitter chip technology with extreme high radiant intensities, high optical power and high speed, molded in clear, untinted PCB based package (with lens) for surface mounting (SMD).

It is certified according to UL268 standard for smoke detectors.




Fig. 1 - Power Dissipation Limit vs. Ambient Temperature




Fig. 2 - Forward Current Limit vs. Ambient Temperature




Fig. 3 - Forward Current vs. Forward Voltage




Fig. 6 - Relative Radiant Intensity vs. Ambient Temperature




Fig. 4 - Relative Forward Voltage vs. Ambient Temperature




Fig. 7 - Relative Radiant Intensity vs. Wavelength




Fig. 5 - Relative Radiant Intensity vs. Forward Current




Fig. 8 - Relative Radiant Intensity vs. Angular Displacement




Fig. 9 - Lead (Pb)-free Reflow Solder Profile According to J-STD-020

DRYPACK

Devices are packed in moisture barrier bags (MBB) to prevent the products from moisture absorption during transportation and storage. Each bag contains a desiccant.

FLOOR LIFE

Floor life (time between soldering and removing from MBB) must not exceed the time indicated on MBB label:

Floor life: 168 h


Conditions: $T_{amb} < 30\text{ }^{\circ}\text{C}$, $\text{RH} < 60\%$

DRYING


In case of moisture absorption devices should be baked before soldering. Conditions see J-STD-033D or label. Devices taped on reel dry using recommended conditions 192 h at $40\text{ }^{\circ}\text{C}$ ($+ 5\text{ }^{\circ}\text{C}$), $\text{RH} < 5\%$.



