






Fig. 2 - Typical Values of Reverse Current vs. Reverse Voltage





Fig. 3 - Typical Junction Capacitance vs. Reverse Voltage




Fig. 6 - Forward Power Loss Characteristics




Fig. 9 - Typical Reverse Current vs. dl_F/dt
