


Fig. 1 - Typical Forward Voltage Drop Characteristics




Fig. 2 - Typical Values of Reverse Current vs. Reverse Voltage





Fig. 3 - Junction Capacitance vs. Reverse Voltage





Fig. 7 - Maximum Thermal Impedance Z_{thJC} Characteristics
