




Fig. 1 - Maximum Forward Current Derating Curve Per Device




Fig. 2 - Average Power Loss Characteristics Per Diode




Fig. 3 - Typical Instantaneous Forward Characteristics Per Diode




Fig. 4 - Typical Reverse Leakage Characteristics Per Diode




Fig. 5 - Typical Junction Capacitance Per Diode





Fig. 6 - Typical Transient Thermal Impedance Per Device
