




Fig. 1 - Maximum Forward Current Derating Curve per Device




Fig. 4 - Typical Reverse Leakage Characteristics per Diode




Fig. 2 - Average Power Loss Characteristics per Diode




Fig. 5 - Typical Junction Capacitance per Diode




Fig. 3 - Typical Instantaneous Forward Characteristics per Diode





Fig. 6 - Typical Transient Thermal Impedance per Device
